Furthermore, we will not provide the information you provide to other parties, unless you have given prior permission for this, this is necessary in the context of the execution of the agreement or we may or must do this on the basis of the law or the agreement.

Data security

Vermes BV uses security procedures to protect the processed data, among other things to prevent unauthorized persons from gaining unintended access to this data. For example, we ensure that only the necessary persons have access to your data and that access to your personal data is protected. In any case, we use a TLS connection for this.

Cookies

Cookies are used on this website to make the website function properly. Cookies are small information files that can be automatically stored on or read from your device (including a PC, tablet or smartphone) when you visit a website. This is done via the web browser on the device. The information that a cookie obtains about your use of the website can be transferred to secure a server from Vermes BV or that of a third party.
